

PERC FFA Chapter Advisor Sweepstakes Official Rules

NO PURCHASE NECESSARY. A PURCHASE DOES NOT INCREASE CHANCE OF WINNING.

Sweepstakes ends 11/30/2020.

ELIGIBILITY: The sweepstakes is only open to those who are current Future Farmers of America (FFA) chapter advisors, legal U.S. residents and 18 years of age or older as of October 1, 2020. Employees of the Sponsor, the Sponsor Affiliates including authorized distributors of the Sponsor's products or any of the members of their immediate family (defined as spouse, mother, father, in-laws, grandmother, grandfather, brother, sister, children and grandchildren) or same household of each are not eligible to participate.
