

PERC FFA Choose Your Adventure Sweepstakes Official Rules

NO PURCHASE NECESSARY. A PURCHASE DOES NOT INCREASE CHANCE OF WINNING.

Sweepstakes ends 10/29/2020.

ELIGIBILITY: The sweepstakes is only open to those who are current Future Farmers of America (FFA) members, legal U.S. residents and 13 years of age or older as of October 1, 2020. Employees of the Sponsor, the Sponsor Affiliates including authorized distributors of the Sponsor's products or any of the members of their immediate family (defined as spouse, mother, father, in-laws, grandmother, grandfather, brother, sister, children and grandchildren) or same household of each are not eligible to participate. This Sweepstakes is void in Puerto Rico, Guam, the Virgin Islands, U.S. Territories and Possessions, and where prohibited or restricted by law, and is subject to all applicable federal, state and local laws.

Entrants may view any or all of the three videos and complete each registration form to be entered into the drawing for each of the three Grand Prizes. Entries must be received by 10:00:00 PM ET 10/29/2020 and must be complete in order to be eligible. Online entries generated by script, macro or other automated means are void. Normal Internet access and usage charges imposed by entrant's online service will apply.
